4. Place of delivery: Reservoir Liptovská Mara - Ratkovo bay

8. Description of the subject of the contract:

2 pieces of round cages, that means:

- floating plastic pipes, size range: diameter 12 m, with accessories
- net for fish for each cage pipe, cylindrical shape, depth below the surface 5 m + 1-1,5m above the surface, width of square mesh 12.0 mm - 16.5 mm
- net against birds for each pipe, width of square mesh maximum 120.0 mm
- transport to the place of delivery – to include in the delivery
- completion - assembly at the place of delivery – to include in the delivery

9. Payment arrangements:

the price of the delivery in Euros, without VAT, break it down into individual components and parts of the delivery

- the earliest possible date of delivery and completion at the place of delivery in accordance with point 6.
- payment conditions in accordance with point 7 b)
- information on the validity of the price offer in accordance with point 7 a)

15. Evaluation of offers:

The evaluation of offers in terms of the conditions of participation and the evaluation of offers in terms of the requirements for the subject of the contract will take place after the offers have been evaluated based on the offer evaluation criteria, in the case of the offer who will be placed first in the order. If the tenderer's offer does not contain all the requirements according to this request, the tenderer will be asked to explain or supplement the submitted documents.

If a tenderer or his offer is excluded, the fulfillment of the conditions for participation and the requirements for the subject of the contract will be evaluated for the next tenderer in the order so that the tenderer placed first in the newly compiled order meets the conditions for participation and the requirements for the subject of the contract.

After evaluating the offers, the tender announcer will immediately send information about the offer evaluation to all offers electronically. The tender announcer will contact the successful applicant via e-mail immediately after the evaluation. A Work Contract will be concluded with the successful tenderer.
